More about the topic and guest speaker:

Topic: *You have done the investigation. The case has proceeded. The prosecutor has procured the conviction or plea, some restitution and justice. Have you ever wondered what happens next? Attorney David H. Parker will present an engaging program regarding the progression of workers' compensation fraud cases through the administrative system post plea or conviction. You will leave with a realistic understanding of what may actually be expected from a fraud conviction, why your work matters and what might be done to better victims' chances at restitution and justice before the Workers' Compensation Appeals Board. Mr. Parker will use a real-life local case to illustrate the possibilities, and limits, of criminal pleas and convictions in a statutory scheme that "shall be liberally construed by the courts."*

Speaker: *Mr. Parker is an attorney and shareholder with Parker, Kern, Nard & Wenzel. His practice includes workers' compensation and employment defense. He earned his B.A. degree from California State University, Fullerton and his J.D. degree from University of Pacific, McGeorge School of Law.
